FIREFIGHTER JOB DESCRIPTION

General Functions:

Responsible technical and professional position involved in the prevention, control and extinguishing of fires in order to protect life and property. A firefighter performs a variety of tasks requiring skill, proficiency and specialized training. Work involves controlling and extinguishing fire, usually performed under hazardous and adverse conditions. Activities require the use of sound judgment and ability to make decisions under stressful or emergency circumstances in accordance with accepted firefighting techniques, practices and procedures. Firefighters provide assistance to the citizens of the community to ensure the protection of life and property. Duties unique to firefighting activities require that work is done according to assignment, and that a significant amount of work time is involved in maintaining fire station and firefighting equipment. Participation in department training programs, drills and exercises is required. A firefighter will participate in specialized emergency medical training and related programs. Work is performed under direct supervision of a superior officer. Work performance is evaluated while in progress and based on observation of results and periodic written reports.

Illustrative Tasks:

Performs equipment apparatus checks; repairs malfunctions and/or reports defective equipment to appropriate department/person for repair.

Maintains equipment and apparatus in clean condition.

Responds to fire alarms and other emergency calls; performs needed rescues, life maintenance operations and firefighting activities.

Selects appropriate hose nozzle type, lays hose line, connects to pump and/or fire hydrants, directs water or chemicals onto fire.

Performs first aid, artificial respiration and oxygen resuscitation as needed, according to training instructions and certification.

Participates in department training and practices street drills.

Learns street and fire hydrant locations; becomes familiar with area and road networks.

Illustrative Tasks continued:

Participates in fire prevention and inspection activities relevant to firefighting activities.

Performs station housekeeping and grounds keeping duties incidental to other firefighting responsibilities.

May drive and operate motor driven firefighting equipment.

Safely operates firefighting vehicles and equipment; drives apparatus to fire or emergency scene; prepares pumping operation; ensures fire hydrants are located, connections made and equipment properly deployed.

Ensures water is pumped to fire at designated pressure; suction hose and fire hoses are properly located; checks condition of motor and equipment during operation; makes necessary adjustments and/or changes.

Performs equipment apparatus checks; inspects and checks pumping equipment, ignition, batteries and brakes; repairs malfunctions and/or reports defective equipment to appropriate personnel for repair.

Gives emergency first aid treatment to injured persons using the application of modern first aid techniques, sometimes involving specialized training including paramedical or emergency medical service.

Completes and maintains logs, forms and reports of activities, according to department guidelines and accepted record keeping practices.

Participates in fire hydrant maintenance, testing and mapping program.

Ventilates fires to release heat and smoke; places salvage covers to prevent water damage; prevents fire from re-kindling.

Performs advanced life support procedures when privileges have been obtained and when assigned.

Performs other job related duties as required by supervisors.

Working Hours:

The shift employees work schedule shall consist of twenty-four (24) hours on-duty followed by forty-eight (48) hours off-duty

Job Description – Firefighter**

This position shall be employed under the terms of the San Carlos Park Fire Protection and Rescue Service District Handbook in conjunction with the Firefighter's Bill Of Rights.

Requirements:

Employee must meet the requirements of Florida Statutes 633.34 and 633.35.

Employee must hold and maintain at the minimum a State of Florida Emergency Medical Technician Certification.

Employee must be able to work rotating shift assignments.

Employee must hold and maintain a valid Florida Driver's License of a class that allows for the operation of fire apparatus, ambulances and other District vehicles.

Proficiency in data entry and confidence with Office 365 (associated apps and programs contained within the Office Suite) and/or any system that may be used by the agency in completing necessary digital tasks and requirements.

Nature of work sometimes requires the ability to perform prolonged and arduous physical activity under hazardous and adverse conditions.

Twelve (12) month probationary period with periodic reviews with annual performance reviews.

APPLICATION PROCESS

Applications will be kept on file for five (5) years per the State of Florida General Records Schedule GS1-SL for State and Local Governments Agencies.

FIREFIGHTER HIRING STANDARDS

As per Florida Statutes, Section 633.412, Firefighter qualifications for employment are as follows:

633.412 Firefighters; qualifications for certification.—A person applying for certification as a firefighter must:

- (1) Be a high school graduate or the equivalent, as the term may be determined by the division, and at least 18 years of age.
- (2) Not have been convicted of a misdemeanor relating to the certification or to perjury or false statements, or a felony or a crime punishable by imprisonment of 1 year or more under the law of the United States or of any state thereof or under the law of any other country, or dishonorably discharged from any of the Armed Forces of the United States. “Convicted” means a finding of guilt or the acceptance of a plea of guilty or nolo contendere, in any federal or state court or a court in any other country, without regard to whether a judgment of conviction has been entered by the court having jurisdiction of the case.
- (3) Submit a set of fingerprints to the district with a current processing fee. The fingerprints will be forwarded to the Department of Law Enforcement for state processing and forwarded by the Department of Law Enforcement to the Federal Bureau of Investigation for national processing.
- (4) Have a good moral character as determined by investigation under procedure established by the division.
- (5) Be in good physical condition as determined by a medical examination given by a physician, surgeon, or physician assistant licensed to practice in the state pursuant to chapter 458; an osteopathic physician, surgeon, or physician assistant licensed to practice in the state pursuant to chapter 459; or an advanced practice registered nurse licensed to practice in the state pursuant to chapter 464. Such examination may include, but need not be limited to, the National Fire Protection Association Standard 1582. A medical examination evidencing good physical condition shall be submitted to the district, on a form as provided by rule, before an individual is eligible for admission into a course under s. [633.408](#).
- (6) Be a nonuser of tobacco or tobacco products for at least 1 year immediately preceding application, as evidenced by the affidavit of the applicant.

As per Florida Statutes, Section 633.404- Additional standards authorized.- Nothing herein shall be construed to preclude a fire service provider from establishing qualifications and standards for hiring, training, or promoting firefighters that exceed the minimum set by the division.

1. Must possess a Florida State Firefighter Certificate of Compliance (Certification as Firefighter II), a Florida State Emergency Medical Technician (EMT) Certification, a Florida State Paramedic Certification; or, at the discretion of the District, any individual

selection/combination of the aforementioned. EMTs and Paramedics must be privileged by the District's Medical Director within one year from the date of employment.

2. Must have a Florida Driver License with a Class "E" endorsement within 30 days from the date of hire. Applicant driving history will be reviewed and must be determined acceptable by this District prior to employment and must be maintained acceptable thereafter.
3. The District will conduct a background check on the applicant, and it must also be found acceptable as determined by the District. Applicants will be required to submit to a set of fingerprints. The fingerprints will be utilized in the background check.
4. San Carlos Park Fire District is a Drug Free Workplace and applicants will be required to pass a pre-employment drug test. Employees of the District are also subject to drug testing throughout their employment.
5. Applicants will be required to pass an oral interview with the Interview Board as well as a second interview with the Fire Chief.
6. Applicants must pass a pre-employment medical physical in accordance with F.S. 633.412; and successfully pass a psychological screening.
7. Applicants must successfully complete both the required CPAT physical ability test and the FireTeam written exam. (<https://www.nationaltestingnetwork.com/publicsafetyjobs/>)
8. Failure to maintain the requirements which were the basis for hiring may result in dismissal
